Prior to processing this order, any changes regarding materials, manufacturing equipment or manufacturing procedures should be communicated to Neville and More Ltd for approval.

If the specification/drawing of the product changes in any way we must be notified in advance of delivery with new drawing, the offer of samples and new material data if applicable. Changes to the weight, the markings, the raw material, the raw material supplier, the tooling, the manufacturing process, the site of manufacture are all of interest to us. Many of our products are purchased for use in licensed products so this is very important and failure to comply with the above could lead to rejection of goods.

Rejected materials must be collected and disposed of at your expense.

All articles supplied to Neville and More must be in full compliance with the REACH regulation no: 1097/2006 and must not contain materials from the most up to date ECHA Candidate List of SVHC.

All articles must contain less than 100ppm total content of Lead, Cadmium, Mercury and Hexavalent Chromium as per the Packaging and Packaging Waste Directive (EU Directive 94/62/EC) effective from 30th June 2001. All articles should be certified against TSE/BSE and not contain Genetically Modified Raw Materials.

#### **QUALITY CERTIFICATES:**
