USER AGREEMENT– Terms and Conditions of Use

We offer this service as an incentive to further our customers' loyalty. As an added convenience, TricorBraun utilizes the ShareFile file sharing website ("Site") to provide design and development information and services to TricorBraun customers.

Our Site is available only to individuals and businesses who can form legally binding contracts under applicable law. You may use the Site only if You are a corporation or other business entity (a "Company") or an individual eighteen (18) years of age or older.

YOU REPRESENT AND WARRANT THAT YOU POSSESS THE LEGAL RIGHT AND AUTHORITY TO AGREE TO THESE TERMS AND CONDITIONS OF USE ON YOUR BEHALF. TricorBraun's standard policy and procedure is to actively copyright and/or patent its original concepts when not performing a work for hire arrangement. TricorBraun considers such work as valuable property that must not be copied or distributed without the prior express written consent of an officer of TricorBraun.

3. You expressly agree and acknowledge that all Content, including all designs and concepts reflected therein, is the sole and exclusive property of TricorBraun and are protected by United States and international copyright, trademark, patent, trade secret, and other intellectual property or proprietary rights laws. You acknowledge and agree that as between you and TricorBraun, TricorBraun is and shall remain the exclusive owner of the Content (expressly excluding Customer Materials as otherwise described in these Terms and Conditions), and all patent, copyright, trade secret, trademark and other intellectual property rights therein. TricorBraun reserves all rights not expressly granted in and to the Content. You may not modify, copy, transmit, display, reproduce, publish, license, create derivative works from, transfer, sell or make independent use of any information, materials, documents, software, designs, drawings, content, products or services from the Site (together "Content") in any form without TricorBraun's prior written permission. 20. These Terms and Conditions of Use will be governed by the law of the State of Missouri, without regard to its choice of law provisions. Any legal action, suit or proceeding brought by it in any way arising out of these Terms and Conditions of Use and/or Your use of the Site must be brought solely and exclusively in the federal or state courts of the State of Missouri. If any provision of this Agreement is held by a court of competent jurisdiction to be illegal, invalid, or unenforceable, the remaining provisions shall remain in full force and effect.

21. The failure of TricorBraun to exercise or enforce any right or provision of the Terms and Conditions of Use shall not constitute a waiver of such right or provision.

22. TricorBraun may at any time revise these Terms and Conditions of Use by updating this posting with the revision date.
